Goal is to promote Healthy Active Living & to encourage community members to attend opening ceremonies for the Rastin event in honor of our First Responders.</p> <p>-The National Kids to Park Day that took place on May 18th, at Ariel Foundation Park was a success. <p>Resilience Team– Susan McDonald, Head Start</p> <p>Smoking Cessation – Mike Whitaker, KCHD</p>	<ul style="list-style-type: none"> -Resilience Film shown in Danville. -Resilience Team plans to form a smaller work group to complete strategic planning meeting. -Seeing some momentum in Triple P parenting classes. <p><u>Tobacco Cessation</u></p> <p>Mike</p> <ul style="list-style-type: none"> -69 adults enrolled in the Tobacco Cessation -The CCI grant is merging into another Tobacco Cessation grant. Name will change. -KCHD did not receive funding to continue Baby & Me grant. Several colleagues around the state also did not receive funds. -KCHD is applying for funds to continue Baby & Me through Women United. Knox County’s pregnant moms smoking at time of del. Is 10%, compared to 7% nationally. -Tobacco 21 – Tami & Mike working to educate all of our local officials. Visited Gambier & Fredericktown Village Council meetings. -T21 is increasing the age that you can purchase tobacco or vaping products from 18-21. This will deter individuals from developing the smoking habit. -Tobacco industry supports T21; however, their enforcement model is not as strong. -T21 is in the state legislatures right now -Next month Walmart & Rite Aid will be taking vaping products off the shelf and they will be implementing their own 21 policy. <ul style="list-style-type: none"> -Carmen has been asked to attend meeting to speak to how KHPP aligns with various strategies. -Carmen’s request to KHPP members...If you are sending people to sub-committee meetings on behalf of your agency, please give them a little background and information prior to them attending. Tami noted that Get Healthy has developed an Orientation Packet for new members. Julie suggested the CHA Executive Summary be added to the packet.
