Resilience Team Discussion - Susan McDonald, Head Start/PPP	Susan reiterates the "re-look" at the Resilience Team and it's initiatives and alignment with state initiatives moving forward. The focus is on developing action steps that can tie into the CHIP and state efforts more easily. No further discussion or questions.	
Financial Authority Discussion - Carmen Barbuto, KPH	Carmen - prior to the merge of PHP and KHPP, if anyone needed money from the KHPP fund, we would go through the PO request and approval process through the health department, with the money no longer in our general fund, we aren't able to do that anymore. However, we have no process set up for spending money, specifically spending KHPP money. This doesn't apply to any of the KSAAT, Project LifeSaver, or UW funds for HD programs - that money is spendable by those groups for whatever they need but we need a process requesting funds. This came to my attention when Tami R. requested funds for the SNAP tokens used at the Farmers Market. Discussion of a small fund request authority up to a certain amount Nick Clark - what would the amount be? 10% of the budget - 1500 dollars suggested by Julie Peg T Can we do a one time motion for Tami's request for SNAP tokens? There has not been any additional guidance from the state, but we have options</li> <li>Skipping a year is not possible but we could look at a smaller assessment potential</li> <li>Peg T we should look at emotional and mental health if we are looking at doing something smaller, should that be our focus?</li> <li>Have to keep in mind the health department state and accreditation requirements and hospital IRS requirements</li> <li>If we proceed with a full assessment, who will we use? Other Business: • Other updates	Kay - Knox County received the federal HRSA grant for rural communities to expand and enhance services for individuals with poor health outcomes, specific to this is individuals with behavioral health issues. Official goal is to reduce morbidity and mortality rates of SU disorders by improving access to sustainable prevention services and will also support population health outcomes and address health disparities Strategies will include: reducing community stigma, increasing MAT, increased screening and early identification of addiction, increasing distribution of overdose reversing medications, implement	

more peer support. Three year, million dollar grant.

Kelly - very excited to announce that we will be launching a volunteer portal to manage and deploy volunteers in Knox County. Every agency and nonprofit in Knox County will be able to have access to this portal. We partnered with Serve Ohio, the statewide volunteer agency. It's free to nonprofits in Knox County. It will be launched in about 6 weeks.

Susan - Excited about partnership with KCH to work with parents of new babies, also working with Mount Vernon Police Chaplains to build a referral system to provide parent educations to both first responders and individuals they met on calls. All parent education is virtual now.

Jan - Back to classes this week and hoping our cases stay low. We tested over 1900 students and so far only one case and it was an employee not a student. Starting our second round of testing on students now. Students at Kenyon seem to be taking things seriously, wearing masks. office for community partnership working on getting all our information updated online and working with partners on how we can incorporate students virtually.

Lori - ND recognized this summer by the state coalition for Excellent in Prevention. Some of the schools are going to allow ND to go into the schools for prevention education. Kenyon and ND partnership and ND wil work will students who are volunteering on on the Kenyon Sexual Assault Prevention group. It is a pilot year but we are confident it will go well and hopefully we can share with the state the success.

Lisa - Foundation still has fund available for COVID emergency grants for any non-profit who may need it

Julie - 249 cases for Knox County this morning, the thing we are most blessed with is that our hospital system has not been negatively impacted, yet. I say yet but who knows with COVID. We are finally at a point where we hope it's leveling off and the health department will be able to move back into focusing on the other things we've been working on.
